This form is to be completed and submitted if you are unable to pay your tuition fees by the due date indicated on your Statement of Account due to these extraordinary circumstances. Please ensure that you contact Student Welfare as soon as possible (details on this form), to arrange an appointment for assessment of either a waiver or extension of fees.

The waiver/extension of tuition fees will only be granted where exceptional circumstances can be clearly demonstrated. Documentation that supports your claim should be attached to this form. However it is understood that where there are difficult situations involving personal tragedy, documentation cannot always be readily sourced. Therefore supporting documentation may be lodged after submission of this form.
